**01. EDUCATIONAL QUALIFICATIONS**

**(A) Temporary Lecturer:**

(1) A Degree in **BBA** with a specialisation in **International Business** with First or Second Class (Upper Division) Honours;

**OR**

(2) A Degree in **BBA** with a specialisation in **International Business** with Second Class (Lower Division) Honours;

**OR**

(3) (a) A Degree in **BBA** with specialisation in **International Business** without honours or any other Degree with at least Second Class Honours;

**and**

(b) (i) A Doctoral Degree in **International Business** or in the relevant field  
**or**

(ii) A Masters Degree in the relevant field obtained after a full-time course of study of at least 24 months duration (or an equivalent part-time course of study) with a research component by way of thesis/dissertation

**or**

(iii) A full time Masters Degree in the relevant field of a minimum of 18 months duration with at least 60 credits\* of which not less than 15 credits\* of research by way of thesis/dissertation

*[\*One credit considered per course unit/module should be in accordance with the Sri Lanka Qualifications Framework (SLQF)]*
