Shall have a minimum of one (01) year of experience in the legal profession following swearing in as an Attorney-at-Law of the Supreme Court.

By an Open Competitive Examination and/ or a Structured Interview conducted by a board appointed by the Appointing Authority

### General Qualifications

All the candidates must satisfy the following :-

- Must have the physical and mental fitness required to perform the duties assigned to the position well as well as to work in any part of the island.
- Should be of an excellent moral character
